OUR CERTIFIED ADVOCATES PROVIDE CRISIS INTERVENTION, SAFETY PLANNING, OUTREACH, EDUCATION, LEGAL ADVOCACY, AS WELL AS ADVOCACY IN SPANISH.

IN ORDER TO PROVIDE A SAFE PLACE TO ACCESS SERVICES, OUR CERTIFIED ADVOCATES ARE STATIONED IN SATELLITE OFFICES IN COTTAGE GROVE, CRESWELL, JUNCTION CITY, OAKRIDGE, VENETA/ELMIRA, BLUE RIVER/MCKENZIE, AND FLORENCE.

SAFEHOUSE - EMERGENCY SERVICES AND SHELTER: OUR SAFEHOUSE PROVIDES 24-HOUR EMERGENCY SHELTER AND SUPPORT FOR SURVIVORS FLEEING ABUSE FROM THEIR INTIMATE PARTNERS. THE SAFEHOUSE TEAM INCLUDES CERTIFIED ADVOCATES WHO SPEAK MANY LANGUAGES AND ARE ABLE TO RESPOND 24/7 TO CRISIS LINE CALLS PROVIDING LIFE-SAVING SUPPORT, SAFETY PLANNING, AND REFERRALS TO OUR PROGRAMS OR OTHER COMMUNITY RESOURCES. THEY ALSO PROVIDE A SECURE AND CONFIDENTIAL PLACE FOR SURVIVORS AND THEIR CHILDREN TO STAY DURING A DIFFICULT AND CRITICAL TIME.
