THE SAFEHOUSE TEAM INCLUDES CERTIFIED ADVOCATES WHO SPEAK MANY LANGUAGES AND ARE ABLE TO RESPOND 24/7 TO CRISIS LINE CALLS PROVIDING LIFE-SAVING SUPPORT, SAFETY PLANNING, AND REFERRALS TO OUR PROGRAMS OR OTHER COMMUNITY RESOURCES. THE CRISIS LINE IS STAFFED BY VOLUNTEERS AND ADVOCATES. OUR ONSITE CERTIFIED ADVOCATES PROVIDE SERVICES FOR WALK-IN CLIENTS EVERY DAY. YOUTH ADVOCATES PROVIDE RESPITE CARE FOR PARENTS WHILE THEY SPEAK WITH AN ADVOCATE. OUR YOUTH ADVOCATE TEAM FEEDS BOTH YOUTH AND ADULTS WHILE PARENTS ATTEND ONE OF THE SEVEN SUPPORT GROUPS HELD EACH WEEK.

WE PROVIDE FULL ACCESS TO THE GROWING SPANISH SPEAKING POPULATION THROUGH OUR RECEPTIONIST AND THE FOUR ONSITE CERTIFIED ADVOCATES WHO SPEAK ENGLISH AND SPANISH. ADVOCATES ALSO PROVIDE WALK-IN SERVICES, FOOD, SUPPLIES, CLOTHING, CRISIS INTERVENTION, EMERGENCY HOUSING, PARENT IN CRISIS TRAINING, DHS CO-LOCATED SERVICES, LEGAL ADVOCACY, AND ECONOMIC EMPOWERMENT TRAINING.
